I understand that 24-hour gym access is a privilege for members only. Under no circumstances am I allowed to bring a guest during non-business hours.

If you allow non-members in after hours

2nd offense: Your **24-hour privilege will be revoked** for 30 days as well as an additional fine.

3rd offense: Your membership will be **cancelled**.
